Requirements: Loan must be opened at least 90 days prior to the month skipped and all accounts must be current to qualify. Only one month's payment can be skipped per loan during a 12 month period. Real estate, VISA and revolving line of credit loans are excluded. By signing, you authorize AAA Federal Credit Union to extend your final payment by one month. You understand that by deferring a payment, the interest will continue to accumulate on your loan during the skipped month, which will increase the total cost of borrowing. You agree to resume payments as scheduled following the month skipped.

<u>Annual Meeting News</u>

AAA Federal Credit Union invites all members to attend and participate in the 73rd Annual Meeting. The annual meeting of the members of AAA Federal Credit Union will be held for the following purposes:

- To receive the annual report of the Board of Directors and the Supervisory Committee, for the fiscal year ending December 31, 2012.
- To announce the results of the election for three openings to the Board of Directors.

Election By-laws

All elections shall be determined by plurality vote and shall be written ballot except where there is only one nominee for each position to be filled. Nominations shall not be made from the floor unless sufficient nominations have not been made by the nominating committee or by petition to provide for one nominee for each position to be filled. Only those positions without a nominee shall be subject to nomination by the floor. When only one member is nominated for each position to be filled, the chair may take a voice vote or declare each nominee elected by general consent or acclamation at the annual meeting.

Nominations by Petition Guidelines

The Credit Union By-laws allow nominations for positions on the 2012 election ballot to be made by petition. Petitions must be signed by 76 AAA Federal Credit Union primary members (not co-owners on joint account), and accompany a signed statement from the nominee that he/she is agreeable to nomination and will serve if elected to office. Nominations by petition must be sent to Scott Singer, Nominating Committee Chairman, AAA Federal Credit Union, PO Box 3788, South Bend, IN, 46619 postmarked no later than March 8, 2013.
